This privacy notice is issued by the Education and Skills Funding Agency (ESFA), on behalf of the Secretary of State for the Department of Education (DfE). It is to inform learners how their personal information will be used by the DfE, the ESFA (an executive agency of the DfE) and any successor bodies to these organisations. For the purposes of relevant data protection legislation, the DfE is the data controller for personal data processed by the ESFA. Your personal information is used by the DfE to exercise its functions and to meet its statutory responsibilities, including under the Apprenticeships, Skills, Children and Learning Act 2009 and to create and maintain a unique learner number (ULN) and a personal learning record (PLR). Your information will be securely destroyed after it is no longer required for these purposes.

The College processes personal data as part of its normal operational activities. Personal data is any information that can be identified to a specific, living individual and processing means collecting, holding or using that information. The College's registered office is 42 Queen Square, London WC1N 3AQ.

The reason for collecting this personal data is so that we make an initial assessment of your educational needs and whether you are entitled to concessionary fees. We are also legally obliged to collect and report on equality data. This helps the college ensure that a broad range of people are able to access our services. There is also information that our main funder, the Education and Skills Funding Agency require as part of their contract with us. This means the legal basis for processing is a combination of being necessary to comply with our legal obligations and to fulfil the legitimate purpose of the College in providing adult education. The information will be used to process your application to become a student. If you decide not to become a student we will delete it immediately. If you do become a student we may keep the data for up to 10 years after you cease to be a student.

This personal data will only be shared with our funder the Education and Skills Funding Agency. The reason we do this is to ensure we receive the funding we are entitled to. We will not share it with anyone for the purpose of sales or marketing without obtaining your explicit consent to do so.

Under UK legislation there are a number of principles that apply to all types of personal data. The individual, to whom the data refers, also has a number of rights concerning their data. Refunds and Transfer Policy

The Centre wants its students to be on an appropriate course and to enjoy their learning. A full or pro rata refund or a transfer will ONLY be allowed in the following circumstances:-

- Where a student withdraws, for a valid educational reason, within 3 working days of the first meeting, from a course longer than four meetings
- Where a student gives 10 working days' notice before the course starts
- Where the Centre cancels, reschedules or closes a course
- Where the Centre cancels more than 20% of sessions of a course

In the case of 1 and 2 above, please submit a request for a refund in writing or by emailing: refundrequest@marywardcentre.ac.uk
 Except under 3 & 4 above, refunds are subject to an administration charge of £10 (£5 concession). We aim to process refunds within 28 days.
 Refunds are made by cheque or onto the card used for payment, regardless of payment method. Cheques not cashed within six months of issue cannot be reissued.

Transfers are subject to any readjustment of fees, room being available on the course and authorisation given by the tutor of the new course.
 In certain circumstances a transfer fee may be charged at the discretion of the Centre.
